- Report from the Police Community Support Officer it was noted that the crime website was still not up to date but this was out of the polices hands as the website was ran by an independent company. An email from PCSO Irving advised that they were planning to hold a meeting for parish councils in each area that they covered every 10 weeks. Councillors found this agreeable depending on the times/dates with evenings being preferable.
- Report from the County Councillor Cllr Fairbairn reported on the following; Road users, in particular motorcyclists and cyclists, are being put at risk by mud and debris being deposited on roads. It is an offence under the Highways Act 1980 to deposit mud on the highway that would interrupt other road users. If a person is injured or endangered as a result of the mud, the person who deposited the mud is committing an offence and may face prosecution or a fine. People working off the highway who may potentially bring mud onto it must do everything they practically can to prevent mud being brought on by cleaning mud from vehicles before they are taken onto the road. This may involve hiring equipment such as wheel washers to remove the mud from the wheels. If mud is brought onto the road the road must be cleaned during the day and at the end of the day. Under the Highways Act the Highway Authority has the power to clean the roads and recover the expense from the person causing the obstruction.
- Report from District Councillor Cllr MacDonald advised that highways had agreed
 to replace rumble strips and signage at the Great Orton junction following a fatal
 accident that occurred this year.
