54/17 Highway Matters

The following highway matters were noted; the Aikton to Moorhouse road is in a poor state and requires re-surfacing, Oughterby to Thornby on the right hand side of the road there is a large pot hole. The white lines at the junction opposite Ashleigh Farm still require painting. The Gamelsby road is covered in mud/slurry. The hedge at the junction in Aikton requires cutting back.

55/17 Common Land Course

Cllr Oliver gave a report on the Common Land &Village Greens course she attended on the 18th of July. The course was given by Hedleys Solicitors. Areas covered included the difference between Common Land & Village Greens, the case of J Pye (Oxford) when the law changed in respect of Adverse Possession; after 10 years the adverse possessor must inform the landowner that adverse possession is to be claimed, land in question should be fenced excluding the rightful owner from it. Possessor Title application – after 12 years of possession of the land they get Absolute Title. Rights of Way (public and private), a definitive map is held and maintained by the County Council. It was noted that it was important that the Land Registry was kept up to date on any changes to land ownership etc. The solicitors were asked to advise on the situation with the Whitrigglees land but had not yet responded.

56/17 Parish Land

The following information was received with regards to how the parish council obtained the Aikton Watering Hole; the place was a watering hole that had gone rather smelly with detritus and as no one wanted the said land given the problem there, it was decided by the parish that they would deal with the water problem and fill the hole in and make a place for cyclists, walkers etc to "take time out". This would be in the early 1990s. It was agreed that Cllr Young check the archives around that date to see if anything had been recorded. Rural Payments Agency to be contacted regarding payments for the land at Whitrigglees.

57/17 First Aid Course

Cllr Young advised that two defibrillators had been donated to the parish; they would be situated at the Aikton Arms & Wiggonby School. Dates to be obtained for the first aid course.
